

Associate Director of Strategic Partnerships

SUMMARY

The Associate Director of Strategic Partnerships works to increase revenue and achieve fundraising goals through corporate partnerships. This position works closely with the Senior Director of Corporate Giving and Strategic Partnerships to develop and execute a program that engages new and cultivates existing corporate relationships in the Greater Rochester and Finger Lakes area. Building the program includes, initiating new and winning back lapsed workplace campaigns; working cross-functionally to create opportunities that meet the corporate social responsibility goals of our partners; and tailors sponsorship packages that elevate our partners' brands. This position will be a member of internal Priority Account Teams serving our top Workplaces. This position also works in collaboration with Marketing, Community Impact, Finance and other departments to achieve United Way's mission and goals and the specific revenue goals of this position

Essential Functions

- Manage day-to-day operations for the Strategic Partnership Program which includes revenue generation from Corporate gifts, Corporate Social Responsibility activities and Sponsorships
- Manage personal workplace portfolio which includes larger-scale corporate accounts.
- Winning back lapsed Corporate support (ie. previous Workplace Accounts and/or Corporate Donors).
- Maintain a comprehensive database within UW Client Relationship Management system (currently Andar and Salesforce) for all corporate partners and assigned portfolio.
- Cross-functional collaboration to create and execute donor engagement opportunities which include, but are not limited to: Workplace Giving Campaigns; Corporate Gift Programs; Program and Event Sponsorships; and Team Building/Employee Volunteer Activities.
- Assist the CDO and Sr. Director of Corporate Giving to conduct discovery conversations with decision-makers within the business community; identify corporate partner goals and tailor a UW corporate opportunity package to meet identified needs.
- Works collaboratively within the Resource Development Team to develop and implement new account development activities.
- Works collaboratively with Individual Giving Team to identify major donors who can open doors to corporate partnerships
- Works collaboratively with Campaign Relationship Managers to review leadership donor data in their perspective workplaces and develop engagement strategies
- Create and deliver presentations
